Zonal Delegate Report Winter EDM 2024

Meetings and Webinars

Since we last reported in Budapest, we have continued facilitating our monthly zonal delegate (ZD) webinars, attended the monthly Steering Committee (SC) meetings, and the bimonthly Conference Participants (CP) meetings.

ZD Webinars

The ZD webinars are held every third Thursday of the month at 21:00 CET and is a place where we have the opportunity of working on anything related to zonal efforts. It is a webinar where we can ask questions and support each other as delegates. It is also the place where we workshop the CAR/CAT and then collect the conscience of the EDM regions who are not represented at the WSC.

ZD Webinars

At the ZD webinars, we discussed and completed the environmental scan survey together with the RD's who attended, providing input to NAWS for phase two of the planning process. The fellowships collective results are posted on the conference page on the website www.na.org

Zonal Planning Sessions

At this EDM meeting we will be discussing the prioritized items which is also happening globally at other scheduled zonal planning sessions. During this phase 3 of the new planning process, zones are analyzing the results of the survey and discussing possible solutions to the challenges we face.

Zonal Planning Sessions

At this EDM, we will be supporting a member of the WB and member from WSO to facilitate the Zonal planning session as part of phase 3 we just mentioned. These will be two sessions of two-hours each to analyze the survey results and discuss possible solutions to the identified challenges. These sessions will be scheduled like the interim WSC days: a two-hour session, an hour break, and then another two-hour session. All of the zonal sessions will contribute to the same strategic plan, and so they need consistent data and a consistent process. That's why a board member and a staff person will facilitate these sessions, and zonal delegates are assisting for those planning sessions taking place in-person at zonal forum meetings.



In addition to these, the ZD supported EDM FD and PR delivering sessions at the Maltese regional convention, which was self-funded and by personal choice. The AZD took part in the Italian regional convention, on request from the region, in a hybrid webinar and shared about the structure of the EDM as a zone and the zonal delegate service position.
