#### **1. EVENT DATE:**

10<sup>th</sup> March 2024

#### **3. PARTICIPANTS:**

Namibian Primary Schools, Namibian Secondary Schools and Namibian Chess Academies

Each School/Academy may register a Maximum of 2 Open Teams with an option of a **3<sup>rd</sup> All Girls Team**.

A Team consists of four (4) Players from the same school/academy. Plyers must be under 20 Years of Age.

#### 4. REGISTRATION PERIOD AND METHOD

#### Primary School Section: N\$ 200 per Team

#### Secondary School Section: 250 per Team

#### Academy Section: N\$ 300 per Team

#### 5. FORMAT, PAIRING SYSTEM, TIE-BREAKS AND TIME CONTROL

- 5.1. The tournament format will be a SWISS System tournament played over 7 (seven) rounds. Swiss Manager will be used to do the pairings.
- 5.2. Match-points will be awarded as follow:
  2 points for a win; (Team scores at least 2.5 wins out of 4 games)
  1 point for a draw; (Team score 2 wins out of 4 games)
  0 point for a loss; (Team score less than 2 wins out of 4 games)
- 5.3. The tie-breaks will be applied in the following order:

Match Points Game Points (Sum of most number of wins) Direct encounter Progressive Score Median Bucholz Bucholz

5.4. The time control will be **30 minutes** per player.

#### 8. APPEALS COMMITTEE

The Appeals Committee will be announced before the start of Round 1. All complaints against any decision made by the Chief Arbiter should be lodged to the Appeals Committee. An appeal fee of N\$ 200 is payable when lodging a complaint. The complainant shall lose the N\$ 200 in the event the Appeals Committee's decision goes against him or her. Complaints should be directed to the individual members of the Appeals Committee. Should a player be unhappy with the initial decision made by such a member, (s)he may appeal. The remaining members would then weigh in and their decision is final.

#### 9. BROADCAST

The Namibia Chess Federation will be Broadcasting the Top Boards in each section of the Primary School and High School Sections.

These games can be viewed on **Lichess.org** and **LiveChess.com** Links will be provided. The Broadcast is in beta test. The NCF does not guarantee that all games can be viewed live and some delays will be set in place.

Future School Teams will be rated based on the success of this event.

#### 10. GENERAL RULES

- 1. Silence at all times.
- 2. Keep the venue clean and tidy.
- 3. No players' mobile phone is allowed in the playing hall, No electronic devices allowed. Parents with mobile phones should switch them off or put them on "silent" mode. No talking on the phone is allowed while in the playing hall.
- 4. No assistance to chess players will be allowed during their games. A player who offers assistance will be expelled from the tournament.
- 5. Each Team must at least have two (2) Players seated for the match to start.

6. If a player touches a piece, (s)he should move that piece, provided a legal move can be made with that piece. (Touch is a move)

- 7. Each player must press the clock with the same hand that moves the pieces.
- 8. If a player makes 2 illegal he/she move lose the game.
- 9. Any player who makes themselves guilty of rude behaviour will be disqualified with immediate effect.
- 10. Players, parents, and coaches should make sure results are entered correctly into Swiss Manager after each round. No results will be amended after a round has concluded and a new one has begun.
- 11. Only players, arbiters and members of the organizing committee are allowed inside the playing area. Parents, coaches, and spectators should all make their way to the designated area.
- 12. The Chief Arbiter's decision will be final unless it is overruled by a decision by the appeals committee. The chief arbiter will have full discretion to in deciding which appropriate penalty to impose on an offending player.
- 13. The Local Organizing Committee reserves the right to amend and make necessary changes to the tournament regulations as it sees fit to ensure a successful tournament. With thanks, LOC
