**\$250 a year rate**

This fee includes 24-hour emergency response telephone number & shipping papers required by the US DOT.

The United States Department of Transportation (DOT) in 49 Code of Federal Regulations (CFR) 172.201(d) requires that "a shipping paper must contain an emergency response telephone number".

In addition, 49 CFR 172.604(a) states, "The telephone number must be:

- Monitored at all times the hazardous material is in transportation, including storage incidental to transportation;
- The telephone number of a person who is either knowledgeable of the hazardous material being shipped and has comprehensive emergency response and incident mitigation information for that material, or has immediate access to a person who possesses such knowledge and information."

Infotrac's emergency response service will provide your company's compliance with these regulations.
