

NSU News-later Summer Session in Roosta, Estonia

The shuttle bus between Tallinn and Roosta

NSU has arranged shuttle busses between Tallinn and Roosta for all participants on the day of arrival and the day of departure. The buses will depart from Tallinn (address: Mere puiestee 5, in front of Vene kultuurikeskus) on 28th of July at 15:00 and 18:00 in the evening. If you are arriving later than 18:00 in the evening, please contact Arrkom so that we can arrange a transfer for you. On departure day, the 4th of August, the buses will depart from Roosta and drive back to the same address in Tallinn at 08:00

in the morning and 12:00 at noon. The bus ride takes approximately one hour and 40 minutes. The ticket prices for the shuttle buses are 8 euros for adults and 4 euros for children. Tickets for the shuttle buses can be bought in advance via our web shop. Public transports is also an option. For more information, see Arrkom's blog page:

Guidelines for new participants visiting the Summer Session

The NSU is founded on democratic values. Participants who are visiting the summer session for the very first time automatically become members and are welcome to share in the work of the NSU on equal conditions as every other participant. Every year, a number of delegates are selected from each circle and region. These delegates are selected in order to represent all participants in the decision making of the General Assembly.

To welcome new participants, and to give everyone a chance to become a part of the decision making process of the NSU, the board will arrange a workshop to introduce the significant function of the General Assembly. This workshop will take place on Monday evening, the 29th of July, between 19:30-20:30. Everyone are welcome to join in this workshop - new members as well as old members. We also encourage participants to visit the homepage before the summer session begins and read about the activities.

Agenda for the General Assembly

One month ago members of the Board of the Nordic Summer University spent several days in Copenhagen for their second Board meeting of the year. Preparing budgets, arrangements for the summer session, writing a new strategy plan for 2020-2023. We met with the accountant to discuss the increasing complexity of the financial reporting. We finalised a first version of guidelines for the Nominating Committee that is to select the new Board of 2020 during the General Assembly. During the General Assembly all the decisions of the upcoming year are made by representatives of the NSU community: what study program will we have, how will we spend the funds that are available to us, who will be in the Board? Important questions, and the Board needs to make sure everyone is informed as much as possible in order to make the democratic processes work optimally.

Together with a local NSU-er who was able to join us, we met with a researcher from the WeValue group from Brighton University to participate in a workshop especially designed to elicit the values of NSU. What is NSU about? Which values do we share as a group? These values often remain implicit, but in communicating what NSU is all about to (new) participants and (prospective) funding bodies, it is very important to be able to put them into words. As we would also like to evaluate the work of NSU on our own terms, we now have very concrete goals and values that can be linked to indicators that we can trace throughout the history of NSU. A very valuable workshop.

On Monday 3rd of June Disa Kamula and Nicole des Bouvrie, chair and vice-chair/treasurer respectively, met with the Nordic Council of Ministers to discuss the 2019 and 2020 funding contracts. Two hours of negotiations with many discussions on reporting, contractual agreements, past surpluses, calls for transparency and an update on the status with regard to the 2014 evaluation of NSU regarding the necessity of external funding. Although we are facing a decrease in funding in 2019 and 2020, we were also able to make sure to protect the independent nature of NSU as an organisation. Overall we aimed for a good working relation while looking at the future of NSU.
