Women's Baltic Peacebuilding Initiative is a women's organisation based on international principals and binding agreements on women's rights, primarily CEDAW, Beijing Platform for Action and SR2000:1325. Our engagements and activities stem from analysis of SDG goal 16, aiming at promoting peaceful societies by building effective institutions for sustainable development. Our interpretation of how to promote peaceful societies is by developing a women's rights perspective on welfare and democratic issues treated holistically. SDG 5, strengthening women's rights, and SDG 17, cooperation between parties, feed into our work. Swedish policy for gender equality stated already in the 1970's that equality between women and men is not an isolated issue and can only be achieved if targeted goals and coordinated activities are set up within a societal context.

Women's Baltic Peacebuilding Initiative cooperate in different projects where analysis of international agreeements are made and Swedish delivery is scrutinized.
