


Context for the creation of the working group

- A brand new working group (WG)
- A lot of legislative developments that the Commission is working on/willing to close before the next European election in 2024 (more than 13 pieces of regulation having an impact on our industry).
- Moving from purely technical to also political: Petcore Europe has a wealth of technical expertise which will now feed into our political engagement (Commission, Parliament, Council).
- Petcore Europe must communicate and work with decision makers, proposing them solutions towards a science based decision making (rather than opinion based).
- Petcore is a PET value chain association representing, amongst others, PET producers, recyclers, converters and users and as such all advocacy actions must focus on the common positions of the value chain
- This new WG will be the interface between the various Petcore's WGs/activities and external stakeholders.



Interaction with internal – external environment






Mission and deliverables of the working group

- Bi-monthly updates for the regulatory developments
- Short free webinars, for Petcore members, related to regulatory developments (twice per year)
- Identify key stakeholders in the area of legislative developments and built interactions with them
- Identify the list of topics on which PETCORE must have a position (pro/con/neutral position) and define if this should be a
 public position or not
- Be connected to the Technical WG's to identify/validate the key topics and ask them to develop the related argumentation for the position
- Set up individual meeting with the above-mentioned stakeholders. The scope of these meeting is to better understand the proposed regulatory developments and provide the position of the PET value chain;
- Invite, twice per year, the stakeholders and present them the benefits, constrains and concerns related to the legislative developments
- Identify activities/forums where regulatory stakeholders present their latest developments and where we can speak on behalf of the PET value chain.
