

Nominations for all the above mentioned Offices and Management positions are invited from Members, all of whom must be in current membership of the Branch, or duly appointed by the Management Committee.

Nominations must be submitted on the Official Nomination form attached to this notice and bear the Signatures of the Nominee, Proposer, and Seconder. Electronic signatures are valid and may be validated.

Nominees may submit a 150 word profile of themselves to be included with ballot papers in the event of an election having to be undertaken.

Voting where required shall take place at the AGM in accordance with clause 6.3 of the Branch Constitution which states:

"Any resolution put to the vote of a general meeting of the Branch shall be decided upon a show of hands based on the 'one Member, one Vote' principle adopted at the 2015 AGM. Therefore, any member present in person shall have one vote only irrespective of the number of offices any member may hold. In the event of an equality of votes upon any resolution, the Chair of the meeting shall have a second or casting vote."

An individual attending the AGM either face to face or virtually as the nominated representative of a Member eligible to vote must, prior to the commencement of the AGM, provide written confirmation of such nomination to the Chair of the meeting (as permitted under clause 12.1 of the Articles of RLSS UK).

If written confirmation is not presented and is not signed by an eligible Member then the returning officer will decide if the authorisation form is accepted or not. If two or more individuals submit authorisation forms for the same Member, no vote will be recorded on behalf of that Member.

The Annual Report and other relevant documents for the Branch AGM will be issued only to Members of the Branch Management Committee, all Past Presidents, Local Managers of the Branch and Affiliated Member Groups.

However, any member of the Branch wishing to receive these papers other than those already mentioned may receive them provided they request a copy from the undersigned, no later than 8th May 2022.

All such requests should be accompanied with a Stamped Self-addressed Envelope **35cm by 25 cm** (A4 document) in size stamped to the value of £1.83.

And whilst referencing National Honours I was proud and delighted to attend the National Honours Ceremony at Worcester and see Branch members and Clubs receive 4 out the 6 Special National Trophies awarded annually by the RLSS UK (full details in the Honours Committee Report). It appears to be without parallel that members of a single Branch have been the recipients of such a large proportion of these Special Trophies.

As a Branch, Kent has always recognised that change happens but we have always responded positively to it. We now face a 'new normal and the national society has to adapt and respond to a new cultural, economic and political environment within which we operate. CHAIRMAN'S REPORT

When COVID-19 hit us in March 2020 little did we know how it would affect us for the following two years and influence our lifestyle for the foreseeable future.

The good news is we are beginning to accept or adapt to leading active lives again whilst accepting the Covid virus will be part of our lives.

The last two years has taught us (in particular me being a more mature member) to embrace technology in a very positive way and use it to share our safety knowledge to a wider audience.

We were able to embrace this technology in 2021 and ran the Kent Branch AGM remotely online on the 27th March 2021. Also during the Lockdown the Society and the Kent Branch management team have carried on their work within obvious constraints running regular online management meetings during the pandemic restrictions. However, it was a great feeling when the management team were able to hold their first face to face management meeting for two years in January 2022.

Our Clubs have tried to remain proactive through 2021 in particular Gravesham Lifesaving Club, Thanet Lifeguards, West Kent Bexley Beavers and City of Rochester SLGC have all reopened their lifesaving sessions in 2021 with Gravesham and Thanet active in their local community.

The SABL team have been able to run some of their programmes online and more recently have been going to small family groups and beginning to see more activity in the early part of 2022.

RLSS HQ have been proactive in looking to the future of the society by holding a virtual Branch Briefing Day meeting early 2022 for the purpose to try and stimulate Branch activity following the full lifting of Covid restrictions that impacted on Society activity for the last two years. The expectation is the Branch will consider their planned activities for the coming year and record their activities on a annual plan to help focus the future activities of the Branch and the Society.

RLSS UK are delighted to announce the launch of the Platinum Jubilee Medallion to mark RLSS UK's Patron, Her Majesty The Queen incredible anniversary. To mark the 70 years of service, RLSS UK has created this unique award based on a modern take of the award Her Majesty completed in 1941.

I am looking forward to a more active 2022. With the encouragement and support form RLSS HQ and the traditional proactive members of Kent Branch I am sure we will see a fuller programme of activity develop from the membership throughout 2022.

Finally, we are immensely proud our very own Debbie Hunt who has been the RLSS UK Deputy President from the summer of 2020 will be installed as the first ever female RLSS UK President from the summer of 2022. I am sure you all join me in wishing Debbie the very best and without doubt she will be a fantastic President of the RLSS UK.

TREASURER'S REPORT

Year ended 31st December 2021

I reported last year that none of us had realised initially the impact that the advent of the Covid pandemic would have on the activities of the Society nationally and the Branch locally. This impact continued through 2021 with activity at the local volunteer level continuing to be severely curtailed, though there was some increased levels of activity recorded nationally as leisure centres emerged from lockdown.

In 2020 the Society introduced emergency spending controls within the Society and its Branches in order to try to secure the financial viability of the Society against the background of significantly reduced income from all sources. These controls included the introduction of a basic block grant to Branches and expenditure control procedures. Automatic payment of proportions was stopped (albeit no award income would have been received). Kent Branch continues be one of the 3 highest income generation Branches of RLSS UK and the Committee recognised the efforts of all members and clubs in promoting the work of the Society within the county.

Membership numbers fell in 2020 to 223 as a consequence of little of no activity removing the need to continue with membership and no opportunities to recruit members. However, data from HQ indicates that Branch membership in Feb 2022 was 323 with most of the growth being in the Licence to Operate and Lifeguard categories reflecting the reopening of leisure centres from the summer onwards.

The 2021 Profit and Loss Account and Balance Sheet for the Branch are shown below. We should note that national accounts go to the Society's Auditors during Q2 and will be presented to the national AGM later in the year within the consolidated accounts of RLSS UK. All RLSS UK members will receive due notice of this and will be able to receive the national accounts at that time. The overall the Branch Accumulated Total Funds rose slightly from £30,149 to £30,620.

The overall financial picture for the Branch is that we remain financially viable, having build up sufficient reserves in recent years to sustain us through to 2023 by which time we may hope that lifesaving activity within the Branch has been able to return to something approaching previous levels.

Two notes of caution though:

- i) Branches have been advised that the funding mechanism for Branches is under review and
- ii) Members who previously ordered awards through the Branch have since September 2021 been using the functionality within Tahdah to order awards and resources directly.

Taken together it is likely that the activity shown pre Covid on the profit and loss accounts will reduce and may in future be a need to increase our own fundraising efforts.

My thanks go to all members, volunteers and supporters tat continue to support the Branch and in particular to the SABL Team whose outstanding efforts results in the receipt of many donations to the Branch each year and also to Stephen Goldsmith who continues to do sterling job as our Awards and Sales Officer

So, what has been happening during the year? Well, twenty plus clubs and affiliated organisations in Kent continue the societies' work of promoting 'drowning prevention' in various forms. Ranging from, training communities, lifesaving, life support and personnel survival techniques.

Pathway progression through RLSS UK award suites and 'Save a life series' Save a Life Gravesham, Save a Child's Life Medway, Save a Baby's Life RLSS Kent, all champion the society's initiative.

Competitions in Kent are very active, and clubs who partake, hold their own, which reflects in the results gained at Regional, National and international championships. Although there has been an absent during Covid, plans are afoot to establish a broad range of competitions for 22. Various clubs within Kent also provide further awareness in the form of outreach work. Local events. Talks and demonstrations.

Outside the club world, organisations are continually providing vocational RLSS UK lifeguard training courses for those who are seeking employment in the swimming pool/beach environments. The RNLI provide a beach lifeguard service for fifteen of Kent beaches and are now actively engaged with local RLSS clubs.

So, what's in store for next year? Continue spreading the message and to extend and engage a larger audience. No big leaps though!

However, through planning, identifying and implementing strategies the impact can strengthen clubs. One initiative being considered is a festival of lifesaving which would capture the elements mentioned above which in turn will raise awareness, further engagement and create and establish partnerships.

One such area that Kent Branch has preliminary taken steps to support, is with Canterbury Lifesaving Club.

REPORT OF THE COMPETITIONS SECRETARY

Unfortunately due to the Covid-19 pandemic restrictions continuing throughout 2021 the branch has not been able to hold any lifesaving competitions. Thankfully the feeling is we are all looking more positively to leading a lifestyle approaching what we are more familiar with pre Covid.

Following this optimism the RLSS UK, after a long wait to get back in the pool competing, introduced and ran the RLSS UK Lifesaving Challenge 2021 in Leeds on the 16th October 2021. The event was well represented from clubs around the country although sadly none of the Kent clubs were able to send any competitors.

There has been a continued nervousness of group meetings at competitions throughout 2021, however, RLSS UK Sport are bringing back the National competitions for 2022 with:

RLSS UK National Speeds Championships

held in Sheffield on 12th and 13th March 2022

RLSS UK National Lifesaving Championships Final

to be held in Leeds on 5th November 2022

In line with the National competitions, Kent Branch propose to run at least two competitions in 2022.

RLSS Kent Lifesaving Championships – September 2022 at Gillingham

Also there will be a South East Regional qualifying championships for the National Lifesaving Final

Following on from this in the RLSS UK National Speeds in Sheffield 2022 she broke the European Female Masters records in the:

100m Rescue Medley with a time of 01'43"82

and broke her own record in the 100m obstacle Swim with time of 01'22"28.

Ending with that positive news!

We are looking forward to a more active year of competitions in 2022.

Save a Life Kent Team 2021 Report

The Save a Life Kent Team deliver classes to the public teaching them baby, child and adult CPR, how to deal with choking, provide drowning prevention tips and how to use an AED. The team is always looking to expand and if you would be interested to join us then in particular read the report from Gravesham.

So another year of maybes, shall we or shan't we. Being dependant on local authority it was another year of the pause button being on due to the uncertainty and respect towards Covid19. So will 2022 be a year of rebuilding – YES! Appointments have been made with 50% of my usual venues. As there is still uncertainty, it has been agreed that the classes will be smaller and less frequent, this will ensure all precautions can be taken to minimise the spread of Covid19 and everyone's well being is considered.

So fingers crossed, I can assist RLSS Kent Branch regain the SABL/SACL unchallenged reputation of excellence.

SABL Medway

Save a Baby's Life Medway classes finally got going again in June of 2021, after a break of over a year due to Covid. Was really good to be back out teaching lifesaving skills again!

Covid was still presenting problems though, and SABL Medway was unable to use the fire station facilities to deliver classes. Not to be defeated, we found alternatives and so delivered classes in people's houses, gardens, local parks, pubs and community centres.

More problems with Covid - we had to limit the number of people attending each class and we were also not able to offer the opportunity to younger members of life saving clubs to come along and get involved. However, despite all this we managed to teach in the safest possible way and delivered 17 classes, reaching 108 people, and had a morning of 5-minute taster sessions at Medway Park to parents of toddlers having swimming lessons.

The good news is Medway Park has offered us the use of their facilities for 2022 and more mini taster sessions are planned. The Army in Gillingham and Maidstone have lessons booked in for 2022, plus we have the opportunity to deliver classes at a Blissful Babies Baby Massage and Holcombe Health Clinic.

So here's hoping 2022 will keep Covid at bay and give us lots of opportunities to reach as many people as possible!

Save a Life Gravesham

SAL Gravesham is the community outreach team from Gravesham Life Saving Club. Like everyone trying to arrange and deliver basic life support training, we have had our fair share of disappointments in trying to deliver sessions through the pandemic, with sessions being cancelled and attendees becoming unwell and having to isolate.

Before the pandemic started, we began a project with The Grand in Gravesend for us to train their young people in adult basic life support and AED use, and then they would fundraise and purchase 2 AEDs for Gravesend town centre to be available to the public 24/7. This is a complex project and continues to be on-going, but we hope to be able to provide the AEDs soon. We have also been heavily involved with the provision of a public access AED in Chalk throughout the recent months, offering advice and helping plan the location of the device. The AED that we manage at the Gravesend Boat was used on a patient following a 999 call recently. Luckily a shock wasn't required from the AED and the patient made a good recovery, but the great thing to note is that the AED was on the patient before the arrival of the ambulance.

During the autumn months of 2021, we started to deliver AED workshops for a couple of the local Parish Councils.

48 people were trained last year in the full range of workshops. For 2022 (at the time of writing), we have trained 26, but we have many more workshops planned.

We have great support from Bridget at the Extra Tuition Centre based at Cyclopark as she has very kindly offered the facilities there for us. For 2022, we have one of the Save a Life workshops every month rotating between baby, child and adult.

As we have restarted these workshops on a regular basis, we have gained more interest from some of our younger club members, and even a couple of former club members as well, in delivering these workshops over the coming months which is fantastic to see.

We are planning a Community Instructors course soon, split over 2 sessions. The first will enable prospective candidates to undertaken Life Support 3 training and assessment, and the second session to train them up to deliver the workshops. We will then be in a position with our regular workshops to give them the valuable experience of delivering the sessions, being supported by the more experienced instructors. If you know anyone who might be interested in attending either of these sessions, please contact us.

We also have plans to attend summer fetes this year, increasing the profile of SAL Gravesham and RLSS UK. To support this publicity, we have produced some A 5 leaflets, and we have also designed our new logo.

Luckily, it would appear we are over the worst of it now, and it's great to be able to say, "We're back!"

RLSS UK Shop understand this may increase the need for manikin wipes and lung replacements.

IMPORTANT CPR MANIKIN HYGIENE ADVICE:

The majority of resuscitation manikins have features that help prevent the spread of infection (including respiratory infections such as COVID-19). Here are the options that can be used for manikin hygiene:

Alcohol Wipes

MUST be used on the manikin to sanitise the face between learners. An emphasis should be placed on scrubbing the mouth area of the manikin. The chest, nose and forehead of the manikin can be wiped too if the possibility of 'hand to hand' transmission is a concern.

CPR Face Shields

For maximum protection we recommend to use wipes and issue each learner with a face shield.

Filter face shields are available on a roll for CPR training. They don't offer complete bio-protection, but they will give a high level of safety when combined with wipes and a manikin that has a one-way valve (see below).

An obvious advantage to a learner using a face shield in practise is that they are familiar with using one if they ever need to give CPR for real.

IMPORTANT NOTE: If a learner re-uses a facemask for repeated CPR practise, they should ensure that the face mask is placed on the manikin same way around each time (so they blow into the same side of the mask each time).

Replacement Airways

Little Anne manikins are designed with a one-way-valve in the part of the airway that sits behind the face mask.

The valve redirects expired air from the manikin's lungs out of the back of the head. This prevents contamination in the lungs coming out of the mouth towards the learner.

Little Anne airways must be **replaced frequently** (at least every course) failure to do this could result in the one-way valve failing. If the valve isn't working properly you can spot this as it becomes impossible to fill the lungs (because air leaks out the back of the head).

Laerdal Baby Anne and Laerdal MiniAnne (inflatable) manikins

The MiniAnne and Baby Anne manikins **DO NOT have a one-way-valve** – so contamination could theoretically be passed from the lungs with shared use.

The lungs must therefore be swapped between every learner practise.

To do this each learner would be issued with their own baby manikin lung. A face shield could provide alternative or additional protection.
