

Rossell Fitness Privacy Policy

This Privacy Policy determines the manner in which The Rossell Fitness Website collects, uses, maintains and discloses information collected from users of the www.rossellfitness.co.uk website.

This privacy policy applies to the Website and all products and services offered by Nicola Rossell of Rossell Fitness

Personal identification information

We may collect personal identification information from users in a variety of ways, including, but not limited to, when Users visit our website, fill out a form or subscribe to the daily email list and in connection with other activities, services, features or resources we make available on our Website.

We will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply personally identification information, or refuse to use the website, except that it may prevent them from engaging in certain website related activities.

Non-personal identification information

We may collect non-personal identification information about Users whenever they interact with our Website. Non-personal identification information may include the browser name, the type of computer and technical information about Users means of connection to our Website, such as the operating system and the Internet service providers utilized and other similar information.

Web browser cookies

Our website may use "cookies" to enhance the User experience. User's web browser places cookies on their hard drive for record-keeping purposes and other times to track information about them. User may choose to set their web browser to refuse cookies, or to alert you when cookies are being sent. If they do so, note that some parts of the Website may not function properly.

How we use collected information

The Rossell Fitness Website collects and uses Users personal information for the following purposes:

To improve customer service

Your information can help us to more efficiently respond to your customer service requests and support needs.

To personalize user experience

We may use information in the collective to understand how our Users as a group use the services and resources provided on our Website.

To improve our Website

We continually strive to improve what our website can offer you based on the information and feedback we receive from you.

To process transactions

We may use the information Users provide about themselves when placing an order only to provide service to that order. We do not share this information

with outside parties except to the extent necessary to provide the service.

To administer a content, promotion, survey or other Website feature

To send Users information they agreed to receive about topics we think will be of interest to them.

To send periodic emails

The email address Users provide for order processing, will only be used to send them information and updates pertaining to their order. It may also be used to respond to their inquiries, and/or other requests or questions.

If User decides to opt-in to our mailing list, they will receive emails that may include company news, updates, related product or service information, etc.

If at any time the User would like to unsubscribe from receiving future emails, we include detailed unsubscribe instructions at the bottom of each email or User may contact us via our Website.

To keep in touch

We offer a PERSONAL training service which means that we take a personal interest in each member of our fitness community. We may use direct mail to send out cards, plans and letters to keep in touch with members, present and past.

You can at any time request for your personal data to be removed from our data base and we will comply with this within the given time frame.

How we protect your information

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, adjustment, disclosure or destruction of your personal information, username, password, transaction information and data stored on our Website.

We comply with the current (as of 20-05-18) GDPR rules laid down and respect your privacy and personal data.

Sharing your personal information

We do not sell, trade, or rent Users personal identification information to others. We may share generic aggregated demographic information not linked to any personal identification information regarding visitors and users with our business partners, trusted affiliates and advertisers for the purposes outlined above. We may use third party service providers to help us operate our business and the Website or administer activities on our behalf, such as sending out newsletters or surveys. We may share your information with these third parties for those limited purposes provided that you have given us your permission.

Third party websites

Users may find advertising or other content on our Website that link to the websites and services of our partners, suppliers, advertisers, sponsors, licensors and other third parties. We do not control the content or links that appear on these websites and are not responsible for the practices employed by websites.

In addition, these websites or services, including their content and links, may be constantly changing. These websites and services may have their own privacy policies and customer service policies. Browsing and interaction on any other website, including websites which have a link to our Website, is subject to that website's own terms and policies.

Compliance with children's online privacy protection act
