
1. WHAT ARE COOKIES?

Cookies are files that can be downloaded to your computer by websites. They are tools that play an essential role in the provision of many information society services.

Among other things, they allow a website to store and retrieve information about the browsing habits of a user or their computer and, depending on the information obtained, they can be used to recognise the user and improve the service offered.

2. TYPES OF COOKIES

WHO MANAGE THE DATA	 <u>First-party cookies</u>: those that are sent to the user's terminal equipment from a computer or domain managed by the equipment or domain managed by the editor itself and from which the service requested by the user is provided. Service requested by the user is provided. <u>Third-party cookies</u>: those that are sent to the user's terminal equipment from a computer or domain that is not the publisher. From a computer or domain that is not managed by the editor, but by another entity that processes the data entity that processes the data obtained through the cookies. In the event that the cookies are installed from a computer or domain managed by the publisher itself but the information collected by means of these cookies is managed by a third party, they cannot be considered as own cookies.
	Time the cookies remain stored in the client's browser
LENGTH OF TIME	• <u>Session cookies</u> : designed to collect and store data while the user accesses a website. They are usually used to store information that is only of interest to keep for the provision of the service requested by the user on a single occasion (e.g. a list of products





• <u>External social network cookies</u> : these are used so that visitors can interact with the content of different platforms interact with the content of different social platforms (facebook, youtube, twitter, linkedIn, etc.) and that are generated only for the users of these social networks. The conditions of use of these cookies and the information collected is regulated by the privacy policy of the corresponding social platform.

3. DISABLING AND DELETING COOKIES

You have the option of **allowing**, **blocking or deleting** the cookies installed on your equipment by configuring the options of the browser installed on your computer. At disabling cookies, some of the services available may no longer be operational.

The way to disable cookies is different for each browser, but it can usually be done from the can usually be done from the Tools or Options menu. You can also consult the browser's *Help menu* where you can find instructions. The user may at any time choose which cookies they want to operate on this website.

You can allow, block or delete the cookies installed on your computer by means of configuring the options of the browser installed on your computer:
