2. Purpose of the processing

We will process your personal data set out in Point 4 below for the following purposes:

- a) to inform you about our activities;
- b) to enable the automated payment of membership fees
- c) to fulfil the needs of ongoing electronic correspondence; and
- d) all other related activities.

We collect this data from former common activities, e.g. former correspondence, former cooperation, etc..

The photos and/or videos serve exclusively the public relations of *Students Connecting Cultures e.V.*

3. Legal basis of the processing

The processing of personal data as well as photos and/or videos (elicitation, storage and disclosure to third parties (see 4.) is carried out with the expressed consent of the primary carer or the person concerned, i.e. in accordance with Art. 6 Para. 1 Letter “a” GDPR. The publication of selected image files in (print) publications of the organiser and on his/her homepage/social media accounts or similar is necessary for the public relations work of the organiser and thus serves to safeguard the legitimate interests of the parties involved, Art. 6 Para. 1 Letter “f” GDPR.

4. Processed categories of personal data

We process the following categories of your personal data on the basis of our prevailing legitimate interest (Article 6(1)(f) GDPR), which is to achieve the purposes set out under Point 2 above:

- Your full name
- Your email address
- Your home address
- Your date of birth
- Your phone number
- Your payment details
- Pictures and/or videos of you

5. Categories of recipients of personal data

For the purposes of automated collection of membership fees, payment data or bank account details will be passed on to the payment processor. Examples for this could be Sparkasse Bodensee or PayPal PayPal S.à r.l. et Cie, S.C.A..

For the purpose of public relations and/or sponsorship requirements, photos and/or videos will be passed on to the association’s own projects and the sponsors of *Students Connecting Cultures e.V.* Examples for this could be the “IstKon Student Exchange” (project of *Students Connecting Cultures e.V.*), the “German-Turkish Youth Bridge” (sponsor) or the “Marmara University” in Istanbul (sponsor).

For public relations purposes, photos and/or videos may be posted on the homepage, (print) publications or social media platforms of *Students Connecting Cultures e.V.*

6. Duration of the storage of personal data

Photos and/or videos taken for the purposes of *Students Connecting Cultures e.V.* public relations work will be stored for an indefinite period of time, subject to revocation of the consent of the person(s) concerned.

Other personal data will be deleted when the person ends the membership in *Students Connecting Cultures e.V.*

7. Right of revocation in case of prior consent

The consent for the processing of the photos and/or videos can be revoked at any time in the future. The legality of the data processing carried out on the basis of the consent up to the revocation is not affected by this.

8. Your data subject rights

According to the data protection basic regulation act, you are entitled to the following rights:

- a) If your personal data is processed, you have the right to obtain information about the data stored about your person (Art. 15 GDPR).
- b) Should incorrect personal data be processed, you have the right to correction (Art. 16 GDPR).
- c) If the legal requirements are met, you can request the deletion or restriction of the processing and lodge an objection against the processing (Art. 17, 18, 21 GDPR).
- d) If you have consented to data processing or if there is a contract for data processing and data processing is carried out using automated procedures, you may have the right to data portability (Art. 20 GDPR).

If you make use of these rights, the person responsible will check whether the legal requirements are met. Furthermore, there is a right of appeal to the State Commissioner for Data Protection of the State of Baden-Württemberg.
