Roles & Responsibilities:

As the PSMF lead at Karo Pharma you will coordinate the preparation and the updates of the PSMF and the summary of the Pharmacovigilance (PV) system to ensure a compliant description of the company's PV system. Main responsibilities:

- Act as the designated PSMF coordinator to ensure the PSMF is legible, complete, succinct, accurate and reflect the current PV system in place

- Ensure processes relating to the update of the PSMF are effective taking into account experience gained, technical and scientific progress and amendments to the legislative requirements
- Support the EU & UK QPPV in providing the Competent Authorities with a PSMF which is succinct, accurate and reflect the current PV system in place immediately or within 7 days of the request
- Ensure that appropriate quality and compliance measures are met with regards to the PSMF
- Developing the quality system in your own area of expertise, as per GVP requirement
