To Chinese Embassador to send to the Minister of Foreign Affairs of China

This letter is intended to provide evidence that the Islamic Regim in Iran is illegal. This dictatorial regime is repeating the grave violations of human rights, women's rights and endangering children. In addition, since coming to power forty years ago, they have consistently sold Iranian lands and any protected Iranian historical resources. The following is a summary of the known violations of the Islamic regime of the mullahs against the lands of our country "Iran".

The Islamic regime in Iran does not have the legal authority and legitimacy to openly sign various agreements in violation of the territorial integrity and inherent rights of the Iranian people. The Islamic regime has no right to negotiate the transfer of natural resources with other countries. The representatives of the Islamic regime in international organizations do not represent the Iranian people, and any agreement reached with them in the last 40 years will not have legal and international validity. Therefore, all treaties and agreements signed by the leaders of the Islamic regime and their representatives are all incompatible with the territorial integrity or interests of the Iranian people and are illegal and invalid.

After the uprising in February 1979, the mullahs took advantage of these demonstrations and seized power. They established a fake referendum on April 1, 1979, to consolidate their power and legitimacy. This referendum According to the one-choice question in form and nature, Was a kind of political fraud and illegal, invalid and worthless. Therefore, the mullahs of the Islamic regime usurped power that year and have no legal legitimacy.

Because of the illegitimacy of the government, the question is: whether this government is the right kind of control over Iran's public affairs, or whether it has the right to conclude international treaties or agreements with foreign governments, or even to be the represent of Iran in the international arenas and organizations?

The leaders of the Islamic Regim know the truth about their illegitimate nature and existence. During the forty years of dictatorship, their government survived by killing, torturing, imprisoning, executing and destroying Iranian history. Their strategy with foreign governments and the international community has been to sell Iranian resources and enter into many infamous international treaties that are incompatible with Iran's territorial integrity and Iranians' right to their God-given natural and national resources, but also to Iran. Unfortunately Colonialism of some countries, including Russia and China, are receiving contracts on Iranian land and waterways from the leaders of the Islamic Republic, promising to maintain the power of the Islamic regime. They are slowly colonizing Iran.

Also, the leaders of the Islamic Regim do not have the necessary authority to enter into international treaties, and some of these treaties themselves have problems. For example, the "Legal Status of the Caspian Sea" and an agreement have been signed at the request of the following countries. Russia, Azerbaijan, Kazakhstan and Turkmenistan. This fact has only one meaning, and that is to take advantage of the current situation in Iran and have a view on the territorial integrity of the Iranians and Iran's ownership of its share in the Caspian Sea. According to the 1978 Convention and the Almaty Declaration, the legal status of the Caspian Sea has been determined.



According to the 1978 Convention, states resulting from the disintegration of other states must comply with their fundamental obligations of secession. On December 21, 1991, the former Soviet republics signed the Almaty Declaration and pledged to ratify the Soviet treaties with other countries. Therefore, it is clear that there is no need for a new legal agreement to request the relocation of Iran's water borders, except as a ransom to Russia to protect the regime.

The leaders of the Islamic Republic are aware of the fact of their illegitimacy, because during these forty years, their only language against the Iranian people is the suppression of torture, imprisonment and execution, and in front of foreign states and the international community, entering into shameful international treaties and agreements, not only maintaining integrity. The territory and property rights of Iranians are in conflict with natural and national resources, but also push Iran towards colonization. Unfortunately, some countries extort money from the leaders of the Islamic Regim by promising water of life and plunder natural resources in Iran.

In addition to the fact that the leaders of the Islamic Republic do not have the right of sovereignty to enter into international treaties, the treaties themselves have objections. Also, delegation of contracts such as "Chabahar Agreement", "Transfer of sovereignty of oil and gas and petrochemical industries to China", "Transfer of Bushehr and Chabahar ports as military bases to Russia" or "Granting priority in the Iranian industrial contracting market to China" It is beyond the authority of the leaders of the Islamic Regime, who themselves do not have the right to govern, and has no legal effect.

In addition to the illegitimacy of the Islamic regime in Iran, this agreement also contradicts Articles 153 and 163 of the constitution of the Islamic regime itself. So, not only is such an agreement illegitimate, but after the overthrow of the Islamic regime, it will also be subject to compensation for China. Therefore, in the interests of the country and the people of China, consider the interests of the country and the people of Iran. This regime is on the verge of collapse, and by standing by a regime that is literally a loser, both nationally and internationally, do not destroy the credibility and history of China for thousands of years.

Entering into such agreements in the long run will cause great losses to the nation and country of Iran and the nation and country of China.
