FelicityESS warrants to the End User as follows:

2. PRODUCT WARRANTY

2.1 Warranty Start Date Definition

For products branded with the FelicityESS logo, the following policies are applicable:

- For the lithium battery with this warranty card you purchased, you receive a FelicityESS warranty valid for 10 years from the date of installation and no more than 10 years and 3 months from the delivery date from Felicity ESS factory or overseas warehouse;
- For the hybrid inverter with this warranty card you purchased, you receive a FelicityESS warranty valid for 10 years from the date of installation and no more than 10 years and 3 months from the delivery date from Felicity ESS factory or overseas warehouse;
- For All in One with this warranty card you purchased, you receive a FelicityESS warranty valid for 5/10 years from the date of installation and no more than 5/10 years and 3 months from the delivery date from Felicity ESS factory or overseas warehouse.

For products branded with the FelicitySolar logo, the following policies are applicable:

- For the lithium battery with this warranty card you purchased, you receive a FelicitySolar warranty valid for 5/7/10 years from the date of installation and no more than 5/7/10 years and 3 months from the delivery date from Felicity Solar factory or overseas warehouse;
- For the hybrid inverter with this warranty card you purchased, you receive a FelicitySolar warranty valid for 5 years from the date of installation and no more than 5 years and 3 months from the delivery date from Felicity Solar factory or overseas warehouse.
- For the off-grid inverter with this warranty card you purchased, you receive a FelicitySolar warranty valid for 2 years from the date of installation and no more than 2 years and 3 months from the delivery date from Felicity Solar factory or overseas warehouse.

2.2 Battery Warranty

2.2.1 Period of Warranty

The parties agree that if any product is found defective during the warranty period, the product shall be repaired or replaced. The battery shall have the following warranties:

For the batteries (**LUX-S, LUX-E, LUX-X, LUX-Y**) branded with the FelicityESS logo, the following policies are applicable:

- In the first year, if there is an issue with the battery cells, they will be directly replaced with new ones;
- From the second to the seventh year, the Battery will be repaired first, and if the repair is unsuccessful it will be replaced;
- From the eighth to the tenth year, only free inspections are provided, excluding labor charges and parts fees.

For the batteries (**LPBA, FLS**) branded with the FelicitySolar logo, the following warranty policy applies:

- In the first year, if there is an issue with the battery cells, they will be directly replaced with new ones;
- From the second to the seventh year, the Battery will be repaired first, and if the repair is unsuccessful it will be replaced;

For the batteries (**HVC**) branded with the FelicitySolar logo, the following warranty policy applies

- In the first year, if there is an issue with the battery cells, they will be directly replaced with new ones;
- From the second to the seventh year, the Battery will be repaired first, and if the repair is unsuccessful it will be replaced;
- From the eighth to the tenth year, only free inspections are provided, excluding labor charges and parts fees.

For the batteries **(LPBF)** branded with the FelicitySolar logo, the following warranty policy applies:

- Standard five-year warranty for all parts including labor charges;

2.3 Inverter Warranty

2.3.1 Period of Warranty

For the hybrid inverter **(T-REX)** branded with the FelicityESS logo, the following policies are applicable:

- Standard five-year warranty for all parts including labor charges;
- For the additional five years, only free inspections are provided, excluding labor charges and parts fees.

For the hybrid inverter **(IVGM)** branded with the FelicitySolar logo, the following policies are applicable:

- Standard five-year warranty for all parts including labor charges;

For the off inverter **(IVEM-LV, IVEM, IVPA, IVPM, IVCM)** branded with the FelicitySolar logo, the following policies are applicable:

- A two-year warranty covers all parts, including labor charges

2.4 All in One Warranty

2.4.1 Period of Warranty

- For the inverter, a standard five-year warranty for all parts.
- For the battery, a 10-year warranty applies. Here's the breakdown:
 - a) In the first year, if there is an issue with the battery cells, they will be

- directly replaced with new ones;
- b) From the second to the seventh year, the battery will be repaired first, and if the repair is unsuccessful it will be replaced;
 - c) From the eighth to the tenth year, only free inspections are provided, excluding labor charges and parts fees.

3. WARRANTY CONDITION

If a device becomes defective during the agreed FelicityESS warranty period and provided that it will not be impossible or unreasonable, the device will be, as selected by FelicityESS:

- repaired by FelicityESS, or
- repaired on local maintenance center, or
- exchanged for a replacement device of equivalent value according to model and age.

In the latter case, the remainder of the warranty entitlement will be transferred to the replacement device. In this case, you do not receive a new certificate since your entitlement is documented at FelicityESS.

4. HOW TO CLAIM

- Please report the defective device to your supplier with this warranty card and pre commissioning completed

- Supplier is required to send the warranty claim form to FelicityESS or Authorized service partner with all the necessary information
- Customers must present this warranty card, purchasing & Installation invoice, and other related materials as well if required
- Please note felicity reserve the ultimate explanation right on this warranty card

5. EXCLUSIONS

Damage to the Products resulting from any of following activities is not covered by this Limited Warranty:

- Breaking the product seal (opening the casing) without proper approval
- Transport damage
- Incorrect installation or commissioning
- Failure to observe the user manual, the installation guide, and the maintenance regulations
- Unauthorized Modifications, changes, or attempted repairs
- Incorrect use or inappropriate operation
- Insufficient ventilation of the device
- Failure to observe the applicable safety regulations
- Force majeure (e.g., lightning, over voltage, storm, fire)
