#### 1. Introduction

#### 2. Definitions

- **Recording:** Video and audio recording may be employed during exams to deter malpractice and facilitate investigations if necessary.

#### 5. Guidelines for Candidates

- **Training and Familiarisation:** Candidates must receive training and guidance on the appropriate use of AI tools before the examination.
- **Responsibilities:** Candidates are responsible for using AI tools as intended, refraining from actions that could compromise the integrity of the exam.

# 6. Malpractice Detection and Consequences

- **Detection Methods:** AI-based algorithms, manual review, and/or analysis of exam outputs will be employed to identify potential malpractice.
- **Consequences:** Any confirmed or suspected malpractice will result in penalties in accordance with JCQ regulations, which may include disqualification from the examination or the entire qualification.

## 7. Reporting and Investigation

- **Reporting:** Suspected cases of malpractice involving AI tools will be promptly reported to the Awarding Body.
- **Investigation:** Thorough investigations will be conducted to validate claims of malpractice, ensuring fairness and due process.

- **Regular Review:** This policy will undergo periodic reviews to incorporate advancements in technology and ensure alignment with JCQ regulations.
- **Amendments:** Changes to the policy will be made as necessary to address emerging concerns or improve the effectiveness of malpractice prevention.
