It is alleged that on the morning of 2<sup>nd</sup> November 2023, Katanga Henry and his wife Molly Katanga picked quarrel which resulted in to a fight at their matrimonial home on Plot 50 Chwa 2 Road Mbuya Nakawa Division Kampala District. In the course of the fight Katanga Henry was shot on the head and died instantly while Molly Katanga sustained injuries and she is admitted at DHK (INTERNATIONAL HOSPITAL KAMPALA) Namuwongo.

NAME OF VICTIM: MOLLY KATANKA

### Examination findings:

- (1) Generalised swelling of back of left hand with two insitu stainless pins (used for fixing fractures of the second and third metacarpal bones).
- (2) Two stitched wounds (sizes: 2cm and 4cm long) on the back of left hand with a big echymosis (size: 8cm wide) along the ulna side.
- (3) Generalised swelling of distal right forearm and right hand with a stitched wound on the back of right wrist (size: 3cm long). There was a big echymosis (size: 6.5cm wide) on the ulna side of right forearm. Tip of the right small finger was gangrenous. There was an insitu stainless pin fixing fracture of the distal right ulna.
- (4) There were echymoses on:
  - (i) lateral right shoulder (size: 20x13cm)
  - (ii) back of left shoulder (size: 10x10cm)

- ⑤ There were multiple stitched scalp wounds.
- Right Parieto-occipital area with nine stitches (size: 9cm long).
  - Right Parietal area with four stitches (size: 6cm long).
  - Left frontal to vertex in the midline with sixteen stitches (size: 16 cm long).
  - "X" fashion on right parietal area with fifteen stitches in total (size: 9cm long x 7cm wide).
  - Inverted "Y" fashion on the left parietal area with eight stitches in total (size: 7cm long x 2.5cm long).
  - Inverted "V" fashion on the left Parieto-occipital area with eight stitches in total (size: 5 x 4cm long).
  - All the above stitches were blue nylon.

⑥ There was a necrotic area on the left parietal scalp area close to the vertex. It was "V" shaped (size: 4.5cm x 3cm x 4cm base).
