**RE: NOTICE OF IMMINENT LEGAL PROCEEDINGS FOR DEFAMATION,
INJURIOUS FALSEHOOD, AND AGGRAVATED PUBLICATION OF FALSE
STATEMENTS**

We act on behalf of Ms. **JOLLY MUTESI, FORMER MISS RWANDA 2016** (hereinafter referred to as "our Client"), and write strictly pursuant to her irrevocable instructions.

TAKE NOTICE that on or about the **16th day of June 2026 at approximately 23:00 hours**, you did, through your verified social media platform (Twitter/X) under the account name **"Bebe Cool,"** published statements concerning our Client, alleging that she was implicated in acts of fraud and/or scamming perpetrated against you in or about the year 2025.

The said publication constitutes grossly defamatory material, which is false per se, actuated by express malice, and published in a manner that was reckless, wanton, and in flagrant disregard of the truth or any duty to verify the same. The imputations contained therein are calculated to disparage, scandalize, and bring our Client into public odium, ridicule, and contempt, thereby irreparably tarnishing her reputation and standing.

For the avoidance of doubt, Our Client has never at any material time engaged in any dealings, correspondence, or nexus whatsoever with you, the telephone

number you purport to attribute to our Client is fraudulent, unauthorized, and bears no nexus whatsoever to her identity and hence your allegations are entirely fictitious, unfounded, and devoid of any evidentiary substratum.

Further, on **the 4th day of October 2024**, one **Tumwine Daniel** did publicly post on his Twitter (X) handle (Tumwinedaniel) the very telephone number, to wit +447731728382, which you now allege to be associated with our Client, expressly warning members of the public that the said number was being utilized by unknown fraudsters to scam unsuspecting individuals and solicit money under false pretences, thereby incontrovertibly demonstrating that the number in question was already widely identified as belonging to third-party imposters and bears no nexus whatsoever to our Client.

Further, you were, or ought reasonably to have been, aware that our Client had on **3rd October 2024**, issued a public advisory via her official platform warning the general public against unscrupulous imposters misappropriating her identity for fraudulent ends. Your conduct therefore evinces constructive knowledge, if not actual knowledge, of the falsity of your claims.

Your actions amount to defamation in its gravest form, including but not limited to libel, and further constitute the tort of injurious falsehood, having been made maliciously, without lawful justification, and with the foreseeable consequence of pecuniary and reputational damage to our Client.

Accordingly, you are hereby required to immediately cease and desist from any further publication or dissemination of the defamatory statements, issue a full, unqualified, and prominently published retraction expressly withdrawing the allegations, publish a written apology in terms approved by us with equal or greater prominence and reach than the original publication, provide a binding written undertaking WITHIN FORTY-EIGHT (48) hours confirming strict compliance, and disclose the source(s) of the alleged information relied upon in making the said publication.

TAKE FURTHER NOTICE that in the event of your failure, refusal, or neglect to comply within the stipulated timeframe, we hold firm instructions to institute immediate and uncompromising legal proceedings against you without further notice.

We further place you on strict notice that your actions may attract ancillary civil and criminal liability under applicable statutes governing cyber harassment, electronic communications misuse, and reputational harm, and our Client deserves the right to pursue all remedies cumulatively and concurrently.

This Notice is issued **WITHOUT PREJUDICE** to all our Client's rights and remedies, all of which are hereby expressly reserved.
