#### **Classes for Members**

Classes will include, but are not restricted to, Gymnastics for All, Tumble Tots, Pre-School and competitive squads.

### Membership

Annual Membership is required for pay monthly classes but not drop in classes. The membership runs for 12 months from when a member joins.

Membership is required after the second session is attended.

Memberships cannot be refunded if a member chooses to stop attending classes. However, you have a seven day 'cooling off' period after payment whereby you can receive a full refund on membership if you change your mind.

After seven days memberships are no longer eligible for refund. If a membership is cancelled, that participant will no longer be able to attend classes that require membership.

#### **Drop-in Classes**

'Drop-in' refers to classes booked via www.bookwhen.com/synergygym These typically include, but are not restricted to, Tiny Gym, Holiday Club and Adults sessions which do not require annual membership and can be booked on a session by session basis (Pay As You Go)

For these classes, SGL operates a no refund policy if you are unable to attend. If you are unable to attend a session that you have booked please view the booking in your email and transfer to another session at least 12 hours before the session is due to start.

However, if the class is cancelled by SGL we will offer either a full refund for that session or the option to transfer your booking to a later date.

#### After-School Clubs

After-School Clubs refer to clubs run and organised by SGL whereby the parent/carer books directly with SGL.


