One candidate had dropped out on 16th October. Of the remaining four candidates one did not turn up for their meeting/interview. The Parish Council agreed to provide extra time for the candidate to turn up. At 7.15pm the Parish Council declared that the candidate was a no-show and began the process of selecting the candidates to be coopted.

The Parish Council invited John Hall and Matthew Jarvis to join the Parish Council as coopted councillors.

The Parish Council was impressed by the extremely high standard of the candidates who attended their meetings/interviews and would like to thank them for their participation in the co-option process.

14.1 Halloween – Pumpkin Carving Project

Cllr Coy had confirmed the budget of £140 for the event.

14.2 Bonfire and Fireworks Event

The total costs of the project would be provided after the event.

Under the Financial Regulations personal credit/debit cards should only be used as a last resort or when there is no other payment alternative. The Working Group had contacted catering businesses who would invoice the Parish Council. The quotes for sandwiches were in the region of £6.00 - £9.00 per head and did not represent best value compared to buying platters of sandwiches from M & S or the supermarkets. Tankersley Parish Council RESOLVED to authorise the members of the working group to use their personal debit/credit cards to purchase fish and chips and sandwiches for provide the volunteers who help to build the bonfire and set up on the day of the bonfire.

Discussions took place regarding the clearing up on Sunday 7 November.

The Clerk was tasked with finding out the What3words reference for the Tankersley Hub.

14.3 Childrens Christmas Party

After much debate it was RESOLVED to cancel the 2021 event.

14.4 Christmas Tree and Lights

Tankersley Parish Council authorised the purchase of 2 Christmas trees for 2021.

Tankersley Parish Council RESOLVED that the Christmas lights should be ahe signatories for the new bank account should be PAT tested.

14.5 Allotment Rent Review

Tankersley Parish Council RESOLVED that the allotment holders of the small plots5A, 12,13 and 14 should not pay as much rent as allotment holders of the bigger plots. The Clerk's recommendations regarding the rent review were noted, Tankersley Parish Council RESOLVED that from 1 January 2022 the annual rent for the small plots should remain at £36 but the rents of the larger plots should rise to £55.

14.6 Community Survey

Tankersley Parish Council RESOLVED that a budget of £5,000 should be included in the budget 2022-23 to cover this but otherwise the item should be deferred until next meeting.

- **14.9.2** monies to cover the costs of the brackets should be included in the budget in case the bid to the Ward Alliance was unsuccessful.
