## **DON'T WORK FOR FREE**

Yes, you are choosing to launch a side hustle but don't forget what you are doing provides value so don't devalue your work or worth, if you don't believe in yourself then others will end up thinking the same.

One of the biggest challenges that people face is finding paying customers, just remember do not fall into the trap of working for free, there is no worse feeling than having to produce something to a high standard and giving it away for free, no matter how good the work is you are telling your customer, it isn't worth it.

Alternatively, there is the option of a free trial which may lead to a long term project or contract but be sure to outline this and get some commitment and targets to hit before producing the work, then let your quality shine through and build upon that relationship to further profit from it. The only other exception to this is volunteering to build up your portfolio or experience which can also be another way of gaining work.



### **BUILD YOUR NETWORK**

A lot of work can come from networking, being in the right circle of peers or simply from referrals, these are some of the reasons why you should be engrossing yourself in the community you are delving into.

Put the feelers out there, engage with key contacts, approach businesses with your ideas, give them solutions to problems you have identified through your prospecting research. Follow the right companies and people on Social Media platforms, engage with them!



A big part of having a side hustle comes from the ability to be proactive, yes you may attract people to you but maximise the potential and don't become complacent. You are the one to make things happen, and this comes into your mindset and your ability to make things happen.



## BE ON THE BALL WITH THE FINANCIALS

Ultimately the more money you make from being successful the more tax you will have to pay, this is just a fact of life and the side hustling world, especially, if you already have a regular, 'main' income stream.

Make sure you do your homework on the implications of tax, consider hiring an accountant if you can who can give you some guidelines so you can make sure you don't get hit with an unexpected bill you have not budgeted for.



#### **REGISTRATION NECESSITIES**

Depending on your location and the nature of your hustle, you may need to register it as a business.

#### **EXPLORING TAX-FREE OPTIONS**

Some side hustles may have tax exemptions. Research the laws in your region to understand what applies.

#### **NO EXPERIENCE VENTURES**

Many side hustles don't require prior experience – think data entry, basic freelancing, or online surveys.

#### **PASSIVE INCOME STREAMS**

Consider options like rental income, stock investments, or creating digital products for residual income.





## DO I NEED TO REGISTER MY SIDE HUSTLE?

Do you find yourself tossing and turning at night worrying about your successful side hustle and the tax man one day coming out of the woodwork and stinging you for a large sum which you haven't accounted or planned for?









#### WHEN TO REGISTER A BUSINESS

Is your side hustle earning income surpassing £1,000 during one tax year?

If so, you are required by law to register as a business. If it is below £1,000 then you could choose to take advantage of trading income allowance. This scenario is whereby UK individuals can make up to £1,000 without having to inform HMRC. Please make sure you bear in mind this relates to income and not profit.



Always do your due diligence and research the benefits of whether using the trading allowance is right for you or if you should register with HMRC regardless of net turnover.



## REGISTERING A BUSINESS WITH HMRC

Depending on your business and your side hustle intentions you may opt to register as a Limited Company, if you have partners or you have work in the pipeline whereby you know you be sending out things such as invoices it is always best to register before you get you side hustle of the ground and running to uncomplicate your end of year tax returns and your self assessments.

### WHAT HAPPENS AFTER YOU REGISTER?

Now you are registered you will receive a very important UTR number to make everything official and a reality. Make sure to then follow the instructions and rules of self-assessment.

Some things to consider if you are doing things yourself are to make sure to keep business records, working out your own taxes and also filling out the end of year tax return which is referred to as an SA100 form, this is done online and needs to be completed by January 31 every year.

You will hear on the radio reminders and also see adverts on television regarding this as HMRC steps up its efforts to give you reminders.



## WHAT TAXES DO I NEED TO PAY?

So now we are all registered you may be wondering what taxes you need to pay to HMRC?

You will be required to pay the following self-employed taxes on your profits:



Income Tax



Class 2 National Insurance



Class 4 National Insurance





Of course, the amounts payable will depend on how much profit you earn through your side hustle and what tax reliefs you are inevitably entitled to.

Please note that things will be different for people who are employed as well as having a side hustle.
