It was **RESOLVED** to respond to the Tiptree Neighbourhood Plan consultation as follows: In any plans for Tiptree, it is vital that a clear distance and visual separation between the parishes of Tiptree and Tolleshunt Knights is maintained.

It was felt that the Plan does not address any infrastructure problems which will arise from further development in Tiptree.

2666/01 TO CONSIDER ANY ITEMS OF CORRESPONDENCE RECEIVED.

Winter Salt bag Scheme. Although there is some salt left over from last year it was **RESOLVED** to ask for a further delivery to the Village Hall.

2667/01 TO CONSIDER A NY HIGHWAYS ISSUES

Drainage problems between 14 and 16 Tolleshunt D'Arcy Road – Highways had advised that no action will be taken at present as the issue is not seen as a priority, but the work was actually carried out since the last meeting.

2667/02 The following issue will be reported to Maldon District Council: A car which has apparently been abandoned at the site of the old Village Hall in Top Road.

2667/03 Trucam report: In May a total number of 39 captures were made in a period of two hours. Patrols will continue with a slight variation in timings.

2667/04 The bench on Factory Hill has still not been repaired. Tiptree Parish Council will again be asked when this work is to be done.

2667/05 The Highways Rangers will be asked to clear the overgrown vegetation at the entrance to Hawthorns off Brook Road. It is not clear who owns this land and is therefore responsible for its maintenance, but enquiries will be made with the Land Registry.

Overgrown vegetation at the entrance of the footpath from Brook Road roundabout to Park Lane will be reported to Highways.
