A resident has raised concerns via the Parish Council website about dog fouling and the prohibition of drones in the playing field. He will be advised of the Council's position on these two issues. The Ride London Women's pro cycling race will pass through Tiptree on 25.5.2024.

It was noted that a person has been allowing their dog to foul in the playing field without clearing up afterwards. Trucam will be asked to carry out a patrol in the field in place of one speed patrol.

3569.01 To consider any Highways issues.

A resident has raised concerns about the increase in speeding in Barnhall Road and the number of large vehicles passing through. Some speed limit signs are damaged or obscured. The signs will be reported to Highways and a letter will be sent to the resident to explain the use of Trucam in the village.

The Trucam patrols in September made a total of 27 captures of speeding vehicles over two hours.

3570.01 Public rights of way report.

The entrance to the footpath from the Brook Road roundabout towards Park Lane is very muddy but it is unlikely that anything can be done given the cutbacks in the budget of the Rights of Way team at Essex County Council.

<u>3571.01 Road Safety report</u> No issues were raised.

<u>3572.01</u> Press Officer's report No issues were raised.

3573.01 Report of the Village Hall Management Committee representative

Insurance claim re subsidence at the Hall: it now appears that the subsidence is due to heave caused by the felling of the ash trees outside the Hall, and the oak trees are not involved. It is hoped that the two insurance companies and other interested parties can meet to discuss the way forward with this issue.

The VHMC is considering a Beer Festival in 2024.
