Minutes of the Ordinary Meeting held in the Village Hall Tolleshunt Knights on 18.11.2024

No issues were raised.

3739.01 To receive apologies for absence, other announcements and Declarations of Interest in the Meeting's agenda items.

Apologies for absence were received from Councillors Mrs Dennis and Mr Long. No Declarations of Interest were made.

3742.01 To consider co-option to fill the current vacancy on the Parish Council

There was some discussion as to whether the Council should temporarily co-opt a person with knowledge of the insurance industry in order to advise on the ongoing issue of the Village Hall, or whether to take them on as a part time employee. It was eventually **RESOLVED** that the best way forward was first to ask the Parish Council's insurer and legal advisor for a remote meeting to discuss the state of the claim and next steps. It was then **RESOLVED** to co-opt Nigel Lewis onto the Council and he duly signed the Declaration of Acceptance of Office and was welcomed as a member.

The Trucam report for October showed a total of 25 captures of speeding vehicles over three patrols, with the highest speed of 45mph in a 30 mile limit. It was noted that Essex Police intend to withdraw two of the sites used in the village as they are considered to be too dangerous.

Most of the highways works carried out under Councillor Durham's scheme have been completed but some repairs are already deteriorating.
