Freedom of Information request Oak trees at Tolleshunt Knights Playing Field

I refer to your request as above. The Parish Council has taken legal advice on this matter and replies as follows:

You asked us:

- 1. Reports from Engineers: All reports from structural engineers detailing the subsidence issues and their recommendations.
- 2. Arboriculturist Reports: Detailed reports from qualified arboriculturists that support the conclusion that these trees are contributing to subsidence.
- 3. Root Barrier Works Quotes: Quotes received for performing root barrier works as an alternative to felling the trees.
- 4. Biodiversity Policy: A copy of the Parish Council's Biodiversity Policy, which should guide decisions on environmental conservation.
- 5. Communications: All emails and letters sent from councillors and the clerk regarding this matter.
- 6. Minutes: The minutes from the council meetings where the decision to fell these trees was discussed and agreed upon. This should include any discussion on alternative solutions and the exploration of funding streams for root barrier works. It is imperative to know what steps have been taken to seek the necessary funds for these alternatives.
