

Privacy Statement of Vores Asylbørn

1. General

We process personal data and have therefore adopted this privacy policy, which briefly tells you how we process your personal data to ensure a fair and transparent processing. Consistent with our data processing is that we only process personal data for certain purposes and on the basis of legitimate interests. We only process personal information that is relevant and necessary to fulfill the stated purposes, and we delete your information when it is no longer needed.

3. What is processed and why?

Your Personal Data as a client, volunteer, subscriber to our newsletter, donator, or just a user of our website, is processed to ensure that we can provide you with the tailored or necessary services you require from Vores Asylbørn. This applies to handling any donations that you may make, unless you prescribe to a means done anonymously. In every case in which we collect Personal Data about you, we will inform you of the purpose of processing your Personal Data.

4. Sharing your personal information and storage?

We do not share your Personal Data outside the organisation without consent. Your Personal Data is also not shared with service providers outside of the EU. Where consented, your Personal

Data may be shared with the Organisation's collaborators that assist us in completing a service that has been assigned to us.

5. Your rights.

You, the Data Subject, have rights as provided by the Regulations. Such as the right of access to the Personal Data concerning you which we process. You can write to us at kontakt@voresboern.dk to request access to the Personal Data that we have registered concerning you, including the purposes for which the data has been collected.

The following are yours rights you are welcome to contact us about:

- 5.1 How we process your data (Duty to disclose);
- 5.2 Which of your data is processed (Right of access);
- 5.3 To correct information (Right to rectify);
- 5.4 To erase or remove information (Right to deletion);
- 5.5 To oppose certain service (Right to object);
- 5.6 To withdraw your consent (Right to revoke);
- 5.7 To limit processing of your data (Limitation of processing); and
- 5.8 To seek disclosure of your data, which you have given about yourself (Right of data portability).

You are entitled to write to the Organisation at kontakt@voresboern.dk to exercise any or more of the information above.

If you submit a request, seeking to rectify or delete your data, we will determine the conditions required for your request to be met which can be made as soon as possible. In enforcing your right to some of your rights may impact our service to you. You are entitled to make a complaint to Datatilsynet, as supervising authority on the handling of your Personal Data.

6. Policy update

Vores Asylbørn is committed to ensuring the security of your personal data and will continuously review and update the data protection policy where relevant. To ensure that we always meet the basic principles of data protection, and that the policy is always in accordance with the legislation.
