# 1. Welcome and apologies,

MP welcomed all to the meeting.

## 2. Presentation:

A presentation from RES on the proposed new project. It was announced that they were in the early stages of looking at developing another windfarm in Kintyre. This would be on Killean Estate and up to 50MW and up to 20 turbines, therefore a section 36 application. They hope to have their scoping request into the Scottish Government by end of September and will then start all the relevant assessments etc needed prior to the planning application. Depending on the eventual size of the wind farm they say they are hoping to go to planning or Scottish Govt. at the end of 2016.

RES announced that they were to meet with WKCC and Tarbert/Skipness CC the following Monday to discuss the setting up of the Freasdail Trust.

West Coast Energy are proposing 14 turbines at up to 150m high. Potentially it will be 6 years before construction begins.
