Dear Members,

Work Permit Holders' Association (WPHA) started its journey in May 2016. Since its inception, it tried to follow its prime objective, which is "Share knowledge and information". WPHA is a non-profit organization that represents all kind of foreign workers in Sweden. According to our constitution, we are entitled to do our annual general meeting at the end of each year. However, the increasing number of deportation of foreign workers during last year made the members very frustrated and the association was unable to conduct the meeting by the 31st of December 2017, which was the due date. As the annual general meeting is an important part of the association, hence without focusing on any other issues, we have administered the meeting for 2017, on February 25, 2018. The association is very proud of its members for attending the meeting.

According to the meeting our agenda was:

- 1. Activity report presentation for years 2016 and 2017.
- 2. Financial report presentation for the year 2017
- 3. Members approval for:
 - a) Reformation of signatory committee
 - b) Reformation of executive committee
 - c) Participation in Almedalenweek 2018
 - d) Introduce a yearly membership fee of 100/SEK.
- 4. Appointing legal expert for the association and members' issues.

In addition to the main agenda we also discussed some other critical factors:

- 1. Foreign workers' integration.
- 2. Synchronization with the stakeholders in relation to information and regulations.
- 3. WPHA website development
- 4. Software and mobile application development for self-assessment. It will help foreign workers to keep tack on their requirements.

A very humble thanks to WPHA and its members for expressing their valuable views and comment. Through dialogues, it has also been proven that very slowly but steadily WPHA has become a significant entity to all kind of stakeholders involved with the matter in question. During the discussion, the impact of different laws and regulations was addressed that resulted in a development through 2016 and 2017. We also highlighted the problems related to the future interpretation of the new law and its impact, which is on the way to be applicable from July 01, 2018.

During last two years, we had numerous dialogues with different stakeholders, for example, spokes persons of various Swedish political parties, trade union organizations, many employers. WPHA also participated several high-level seminars and meetings during the same period as well as actively took part at the Almadenween and Järvaweek during mid-2017. This events and exposures made it very clear that the current challenges for foreign workers proliferated due to the lack of knowledge, information and synchronization of the requirements from the Swedish Migration Agency and foreign workers' real situation among the vital stakeholders. However, all the stakeholders gave importance to strengthen the synchronization process and that is why WPHA needs to continue its work in the coming years.

Additionally, WPHA will concentrate on three other factors during the year 2018:

1. Foreign workers' integration

Foreign workers in Sweden are much diversified from a different perspective: nationalities, professions and, skills. Everyone is living in the same society and contributing to the same economy. Therefore, it is very important for WPHA to reach out to more foreign workers and help them to integrate into the Swedish society and economy.

2. Website development

Our website is our identity. Therefore, we need to make it more resourceful and user-friendly. This will be a continuous process so that the workers and stakeholders are always updated in terms of information, regulations, and practice.

3. Software and Mobile application development for self-assessment

The Swedish Migration Agency become very stringent about adhering to the work permit visa requirements for the foreign workers, especially in last two years. Therefore, neither the employers nor the employees could follow their track on a regular basis. A software or mobile application can help both job providers and workers to keep track of all their information and criteria. This can also distinguish any variation between regulations in the books and in practice.

Similar to any other organization, WPHA requires funds to run its internal operations as well as many external activities, for example, printing, publishing, arranging seminars and such. In this context, WPHA proposed a yearly membership fee of 100/SEK. It has been well appreciated that the members decided that instead of setting up an arbitrary amount the association will publish its quarterly or yearly budget and will request its members for financial support accordingly. Financial help can also be sought from the Swedish Government and related stakeholders.






